

What is this document about?



If you hire a worker, you need to work out if they are an employee or a contractor.



This is important because it changes who pays the worker's tax – paying a part of their income to the government.



It might also change who pays the worker's superannuation – money for their retirement.



It also changes:

• how the worker gets paid

This guide explains the differences between employees and contractors.



You can use these differences to decide if your support worker is an employee or a contractor.

Employees



Employees can't pay someone else to do their work.



Employees are usually paid based on how many hours they work.



You give your employee the equipment they need to do their job.



You are responsible for the work your employee does.



You can tell your employee how they should work, including:

• what they should do



• where they should work



• when they should work



• what they will be paid for the work.

Contractors



Contractors can pay other people to do their work if they want to.



Contractors are paid for finishing the job they were asked to do.



Contractors bring their own equipment to do the job.



Contractors are responsible for their work.

If something is wrong with their work, they have to fix it.



Contractors run their own business.

They decide how a job should be done.
