

#### Definition

"The process whereby a person with a disability is enabled to make and communicate decisions with respect to personal or legal matters."

(UN Office High Commissioner for Human Rights 2009)



### Supported decision making steps

- Building capability to recognise the role of decision making, the right to equality and self-determination
- Learning about decision making
- Recognising and expressing a decision
- Identifying and establishing support
- Exploring a decision
- Accessing information to inform a decision
- Advocating for the decision
- Fulfilling the decision
- Ongoing support for another decision.





#### Context

- National Disability Strategy
- Australian Law Reform Commission Report 'Equality, Capacity and Disability in Commonwealth Laws'
- Various state based legislation reviews and reports
- Pilot projects





#### ALRC Principles:

- ► Everyone has the right to make decisions that affect their life and have those decisions respected.
- Persons who may require support in decision making must be provided with the support necessary for them to make, communicate and participate in decisions that affect their lives.
- ► The will, preferences and rights of the person who may require decision making support must direct decisions that affect their lives.
- Decisions, arrangements and interventions for persons who may require decision making support must respect their human rights.





# Stakeholders – community engagement

- ► Genuine Co-design
- ► Commitment from all governments
- Agency with responsibility to ensure sustained implementation



# Safeguards – reporting, regulation, oversight

- For the SDM process
- For people using SDM
- For supported decisions





#### Risk

- The aim is NOT to eliminate all risk
- ► Balance dignity of risk against duty of care





#### Language – consistency

- Formal and informal decision making
- Legal capacity and decision making ability
- Support for decision making and support with decision making
- Assisted decision making, co-decision making and supported decision making





### Resources – capability building, funding

- Long term commitment
- Embedding SDM requires cultural change
- Cultural change takes time






#### Innovation and Sustainability

- Keep the conversation going






# Government responses
